## MEMORANDUM ORDER NO. 40

UDATING ALL MEMBER AGENCIES OF THE COUNCIL FOR THE WELFARE OF CHILDREN TO PROMOTE AND IMPLEMENT RELEVANT ASPECTS OF THE PHILIPPINE PLAN OF ACTION FOR CHILDREN IN THEIR RESPECTIVE DEPARTMENTS, INCORPORATE THE SAME IN THEIR MEDIUM-TERM DEVELOPMENT PLAN (1993-1998) INPUTS AND ALLOCATE FUNDS THEREOF.

WHEREAS, the Philippine Plan of Action for mildren is the commitment of the government to the prid Declaration on the Survival, Protection and evelopment of Children in support of the Convention on the Rights of the Child;

WHEREAS, it is a comprehensive plan of action for ldren which outlines the goals and targets to be ieved and strategies which have to be undertaken by State;

WHEREAS, on January 31, 1992, Proclamation No. 855 issued directing the different line agencies of the cil for the Welfare of Children, the principal cy mandated to coordinate the implementation of the to submit their programs of action and undertake operationalization of the plan through its onal, regional, provincial city, municipal and ngay mechanisms;

WHEREAS, the Philippine Government shall be porting to the International Committee on the Rights the Child on September 1992 and every five years ereafter with the plan as its basic framework;

NOW, THEREFORE, I, FIDEL V. RAMOS, President of Republic of the Philippines, by virtue of the s vested in me by law, do hereby order:

SECTION 2. The national agencies covered shall promote and implement the relevant aspects of the Philippine Plan of Action for Children within their respective departments, and if necessary with their regional offices.

SECTION 3. The agencies mentioned shall likewise incorporate relevant program agenda of the Philippine Plan of Action for Children in their respective sectoral input to the Medium-term Development Plan (1973-1978).

SECTION 4. Appropriate funds shall be allocated from the agency's budget to ensure its implementation.

SECTION 5. This memorandum shal take effect nediately.
